CALL TO ORDER:

Supervisor Chilson opened the meeting at 7:07 PM. The minutes from the June 19, 2017 Regular Meeting, June 26, 2017 Special Meeting, Clerk and Court reports are approved as presented by the Clerk.

VISITORS:

1. Paula Stockman – Meeting scheduled w/ Michael Bogardus, Joe Pilliteri & Mark Burr at the County. No news on Tannery Bridge.

REPORTS:

Highway – Ritter and Snyder Hollow Roads have been oiled and stoned. Truck prepped for new box installation. Highway has both given and received assistance to/from other municipalities. Supt. Rupp is working on a multi-year plan and attending the Cattaraugus County meeting for shared services; he is interested in the equipment listing within the County. The Clerk's office will stay open until the Bid Opening at 5:00 PM on August 10, 2017. Supt. Rupp is working with the Soil Conservation office on a possible 4-year grant to assist with erosion and line drainage. Requirements include a commitment to 2 miles overall (not continuous).

Code – Building Permit granted for a pole barn on Leon Road. Demo Permits granted on Waite Hollow and Tug Hill Road. A cell tower will be removed on Tug Hill Road. Mr. Sheridan of New Albion Road is inquiring into a limited residential use of his property on New Albion Road. Code Officer is waiting for well and septic plans. Clerk – The register report for June was previously distributed to Board members.

Treasurer – CHIPS reimbursement expected in September. Once received, the \$108,000 FEMA reimbursement will be transferred from HDB to Highway Capital Bridge Project.
