2. Police: The move upstairs will take longer than anticipated. The wall needs to be a specific color for mugshots and such. It takes a long time to get it perfect and there needs to be better lighting upstairs. They took in a man on a warrant with the help of the sheriff's department. He handed in an early draft of his budget. He's looking into a grant for bullet proof vests. He needs a written estimate for stump grinding and tree replacement at the church. The cops will patrol after midnight to take care of the vehicles parked on the road and interfering with plowing.
3. Code Enforcement: He sent a cover page for the variance for the shed. He needs it back to have the hearing. Some notices have reached the 30-day mark. He has seen some improvement. No new permits. This is the slow season.
4. DPW Superintendent: Mr. Wolfe would like to take a look at the lot intended for the senior center. Trees and sidewalks were discussed. The board has no issues with the bandstand being decorated for Easter. There are no water issues. The reports are all done. There was a meeting with the Alianello's and they expect to be laying pipe this year. They are ready for easements. There needs to be a water district.
5. Clerk: Looking for a new deputy clerk. Currently taking applications.
