PUBLIC COMMENT

1. Cindy Eaton, *Town of New Albion Board:* The Town of New Albion is in financial distress. The board is asking that the village increase the rent in increments, rather than doubling it at this time. The town is dealing with 3 bridges that need repairs, the formation of a water district, and has already made many cuts to the highway department. The village board is happy that someone from the town finally approached them and they are happy to help and increase the rent slowly. The increase is necessary as the town does not currently pay for their share of the utilities and equipment.

He would like to start bidding for project materials as soon as possible. The Penn-York easement needs to be further discussed. The new truck is here. He would like to look into purchasing a building in the village.
3. Code: 2 houses in the village are being rehabbed. Will be contacting the owner of the old school this month.
4. Clerk: Trick or Treat hours need to be set.
