Mayor Smith called the meeting to order at 7:02 p.m. The Pledge of Allegiance was recited.

PUBLIC COMMENT

John Gibbs: Came in to discuss a water bill for one of his rental properties in the town, stated he was unaware that there was anything owed, even though he gets the bills mailed to his house, and a payment hasn't been made on this account since November 2018, and was led to believe by his tenant that the water had been shut off. He was informed that the water was shut off in August due to non-payment but never officially shut off through the office. He asked that the last two bills and all penalties be removed from his bill. Mayor Smith informed him that according the water law he is responsible for the bill since it was not shut off and he was billed the minimum even though no water was consumed. The only thing that could be forgiven would be the penalties.

They ran into some issues with bedrock, which set them back a few days. A change order will probably be submitted because of this. The Cobo Well/Kenyon-Mayo transmission line should be able to stay mostly on the right of way. 2 easements will be needed. There is a need to better define the current easement at the Gross property. It would be smart to replace the current 4 inch pipe with 6 inch to better capture the water produced by the spring.
